# 6. PRESENTATION BY A MEMBER OF THE PUBLIC CONCERNING A PROSPECTIVE NEW DEVELOPMENT

The Chairman explained that the main purpose of the presentation is to learn more about the development proposals and its implications, not to form a view or make decisions, and that any meeting is conducted on a without prejudice basis.

Sean Preston attended from Chalk and Weald Ltd to present his proposal for a 3.3 acre development of commercial units at the Old Kennels and Cattery site next to the Old Brickworks site on the London road between Henfield and Small Dole. This site has been included in the Henfield Neighbourhood Plan as site G, noted as suitable for commercial development, as well as two other sites adjacent, E and F. Current buildings would be demolished and two new buildings erected to consist of a headquarters for Southdowns Engineering, a transport and hire company, and one other to consist of starter units made available for lease. Soft landscaping has been considered with the majority of planting to be retained. There will be extensive parking, solar panels and EPC's are predicted to be high. Business activities will take place at Southdown Engineering five and a half days per week. WSCC highways have been consulted and a ghosted right turn lane on the road will be included as well as a pedestrian island. Cyclists will also be catered for. Chalk and Weald Ltd have already been through the pre-application stage with West Sussex County Council

(WSCC) and Horsham District Council (HDC) and plans are almost ready to submit to HDC.
