The Chairman noted that there are two adjacent sites to this and asked whether a common entrance for all three had been discussed. Mr Preston confirmed that this has been discussed but is not part of his plan. Cllr Rickard asked whether there would be continuous pavement from the bus stop to the site as on the plan it appears to stop short. Mr Preston confirmed that this is because it is West Sussex Highways land but this will be rectified.

Roger Minost was in attendance representing his clients who own the Station Stores site. He asked for advice from the Committee on the aesthetics of the proposed development in terms of architectural style. The Chairman advised that flat roofs on the roadside of buildings are not in favour with Horsham District Council (HDC). He also advised that HDC will consider whether the style will fit with the frontage of the rest of the properties on that road. Cllrs Rickard and Shaw commented that it would be appreciated if the design was made to look more attractive. The Chairman commented that he felt the committee were broadly supportive of the plans, in particular to provide a number of small affordable one-bedroom homes.
