3. APPROVAL OF MINUTES OF MEETING HELD ON 3RD DECEMBER 2020

OPEN FORUM

The first member of the public said that he wanted to listen and did not have any comments to make.

The other member of the public said that he hoped that all committee members had had a chance to see the plans that he would be submitting to Horsham District Council (HDC) and wanted feedback before submission. He had a collection of Classic Cars which were used to raise money for the Haven and other worthy causes. He wanted to remove an existing concrete garage and build a new one which would be invisible from the road and next door to the row of garages at Spring Hills. He confirmed that it would have a single screen brick wall and no windows so it would not be suitable for accommodation. He would then move his cars from a unit at Henfield Business Park.

Cllr Eastwood said that he would want it to remain ancillary to main dwelling he agreed with that. Cllr Perry asked whether the trees had already been planted and he said that they had cleared away some smaller trees in order to allow a number of specimen trees including rowans to flourish. The garage had been planned to avoid danger to the trees. Cllr Rickard asked how many cars it would hold and he confirmed that it could hold six to seven cars. The Chairman wished him well with the project and Cllr Eastwood thanked him
