# 11. ANY OTHER URGENT MATTERS TO BE RAISED BY COUNCILLORS

Cllr Eastwood said that he was very disappointed by HDC response to the tree felling of the Cedar under a TPO at Corpus Christi Catholic Church. All agreed that the Clerk should write to HDC Planning and Emma Parkes (Head of Planning) to voice the concerns of this Committee and Cllr Eastwood agreed to prepare the letter.

**ACTION POINT:** Cllr Eastwood would prepare a letter for the Clerk to send to Planning Department and Emma Parkes at HDC.

Cllr Eastwood was also raised concerns that Pear Tree Farm are storing vast quantities of plastic wrappings from pipes and were a risk to livestock in field next door and that they were using the land for parking neither of which is allowed. Cllr Eastwood had already spoken with both Cllrs Morgan and Potts, and all agreed that the area was an eyesore. It was agreed that the Clerk would write to Emma Parkes and the Planning Department at HDC and recommend they pay a visit to see for themselves the site.
