- "Body" means a firm in which either of you is a partner or a body corporate of which either of you is a director or in the securities of which either of you has a beneficial interest. "Director" includes a member of the committee of management of an industrial and provident society.
- <sup>v</sup> "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income.
- vi "Securities" means shares, debenture stock, loan stock, bond units of a collective investment scheme within the meaning of the Financial Services and Markets Act 2000 and other securities of any description, other than money deposited with a building society.
- vii "Sensitive Information" means information whose availability for inspection by the public could lead to you or a person connected with you being subject to violence or intimidation.
