- vii "Sensitive Interest" means the nature of the interest is such that the councillor and the Monitoring Officer consider that disclosure of the interest could lead to the member to being subject to violence or intimidation.

Disclosable Pecuniary Interest' is defined in the Relevant Authorities (Disclosable Pecuniary Interests) Regulations 2012/1464 and includes matters set out in questions A to G inclusive of this schedule.
